- Minor penalty for not having one in. After one warning to the bench, a misconduct for wearing Mouthguard improperly.
- Teams include: all city teams Sh. Pk, St Albert, Spruce grove, Beaumont, Fort Sask, and Leduc.

Bantam AAA:

- Mouthguards are mandatory for all players including City Goaltenders. Out of city goaltenders do not have to wear a mouthguard
- It is a minor penalty for improper wearing of or not wearing a mouthguard at all.
- If a player has been previously penalized for the mouthguard infraction, and he is not wearing it properly or not at all, the player shall be assessed a 10 minute misconduct.
- The Mouthguard does not have to be colored.

Bantam AA:

- Mouthguards are mandatory for all players including Goaltenders.
